

# **OVERVIEW**

Aircraft maintenance records, often a disparate mix of paper and digital assets, are extremely valuable, they are not usually insured and could require significant research, reconstruction and re-work if they are lost or damaged. Further, maintenance research, records organization and compliance can be time consuming and costly. Finally, with maintenance personnel in short supply and wages at a premium – it's clear that a digital solution will mitigate risk, reduce costs, increase efficiency, and aid with ESG compliance.

Mente Group, a well-established aviation asset advisory firm, consulted with Bluetail, the leader in aircraft records management tools, to explore their market value proposition. Mente Group conducted independent research consisting of multiple in-depth interviews with clients of Bluetail, other industry stakeholders, and found that Bluetail's business aviation solution can address specific challenges across organizations to preserve value, reduce workload and increase efficiencies.

# MAINTENANCE TEAM CHALLENGES

Customers interviewed noted three major issues managing maintenance records for their fleets. Below are the most universal concerns.



#### Aircraft records inefficiencies

Doing maintenance research using paper records, otherwise known as "box diving", is a very time-consuming process. Even digital records, if not indexed properly - an often labor-intensive exercise - are typically not fully searchable nor are they easily organized.



#### Need to do more with less

Maintenance organizations are under constant pressure to increase productivity and reduce costs, with labor shortages only exacerbating this challenge. Digitization is seen as a major catalyst for helping do more with less.



#### No centralized records "hub"

The current aircraft records solution is a disparate mix ranging from analog (fireproof safes, filing cabinets, etc.) and digital records which originate from MX-tracking/ERP systems and scanned records stored in desktop computers, flash drives and FAA non-compliant cloud storage solutions.
